Production Manager's Report for BoD Meeting 04 Oct 07

Goals for Sept 2007 – May 2008 prepared by Jill Staveley

Local Music Archive Database: It's almost ready. All of our local music tracks have been copied onto the LMAD computer, and the database is mostly updated. The last remaining task is to create m3u files and hyperlinks for each of the artists/bands. Once this task is created, the computer will be prepped for it's use in Sadleir House's Alternative Resource Library. Plans for updating and maintaining the resource still need to be confirmed, and prepared. I expect that we will want to do this every 4 – 6 months.

Listening Station: It is becoming more and more apparent that, though this is not directly a priority for "on-air" radio, it is a resource that needs to be realised for our Programmers in the very near future. With more workshops being held in an attempt to engage our Programmers with music available to them, a Listening Station outside of our studios needs to be made available. This station will also decrease use of StudioB for the creation of playlists and preparation for shows, and will help in preventing Programmers from downloading .mp3s to their PSRV folders from online resources that they are more familiar with than our digital music archive. This resource will also provide Programmers with the opportunity to practice using WinAmp, become more familiar with the creation of m3us, prepare for their shows more thoroughly, and increase professionalism in the on-air studio when using our digital music archives. We are currently in negotiations with Sadleir House to receive a functional computer that would meet out needs, as we will be moving our LMAD Computer to the Sadleir House Alternative Resource Library.

Spoken Word: Our main goals for the Spoken Word Archive this year are to (a) organise and update written records of the archive, (b) maintain a swift pace of ingesting the tapes and (c) make the archive more accessible to our Programmers. This will be an ongoing project until we find the best methods, and have actually spent the time looking into what tasks need to be completed and dealt with.

Community Profiles: I fully intend to continue on with this project. It is a great way to highlight members of our vibrant community, draw their attention and ears to Trent Radio, as well as create an archive of life in our community that can be listened to by future Trent Radio generations.

Incoming Music: Christina Last will be returning as our Music Archivist. Our main goals this year will be to (a) keep on top of all incoming music, (b) provide more information about our incoming music, especially touring bands, to our programmers, (c) respond directly to tracking, and other music submission inquiries via the jreno@trentradio.ca email account, (d) clean up and maintain order in the archiving storage system, (e) rotate the CDs in Studio A on a monthly basis, and (f) start working on the vinyl – again – in November.

Scheduling will be much easier this year, as we only have 2 archiving positions to work around. This will free up Studio C for more projects including workshops, live broadcasts, radio drama production and a plethora of possibilities.

Assistance for Technical Projects - needs to be better defined: Every year we find ourselves with a different group of people, who have varying radio & technical skills. It is difficult to anticipate what will happen each year. Thus, I propose that we have set hours during the week that are geared toward people using Studio B as beginners. During these hours, technical assistance can be made readily available, especially encouraging people to NOT feel "bad" for interrupting us. These times can either be officially posted, or this information can be passed on to Programmers during Studio B Training Sessions.

Repairs: It has been evident, in general, that when gear is broken, wonky or ill, there doesn't seem to be a clear path of communication. I have prepared a "Damaged Gear Report Form", for programmers and/or operators to fill out when they come across damaged gear. There will be a folder in the Operators room where these sheets can be dropped, and a Maintenance Log in the Office to track damages & repairs. **StudioC Projects:** As I stated in my last report, I am quite looking forward to spending more time using the facilities in StudioC for educational, programming, and creative projects this year. We don't have any specific projects lined up at this point, but the possibilities are endless, and my ability to focus my energies on Trent Radio this year will prove to create a space of enhanced productivity.

Contract Obligation & Loan Arrangements Report for BoD Meeting 04 Oct 07

While we have done very well in fundraising for the new transmitter, at year-end we find ourselves about \$25,000 cash debt, about \$17,000 more than expected. This is in part due to Trent University's nine month delay in forwarding about \$12,000 in student fees (due Jan 07 & delivered Sep 07), and change in the City of Peterborough's granting system.

This next year will be critical in establishing whether we can sustain 2-1/2 full-time positions, and deciding if this staffing structure achieves the goals we've set out for the organisation.

At the time of writing we owe about \$48,000 under a contract obligation and a further \$15,000 from borrowing made over this past summer. Paying out the contract obligation according the current schedule and the current loan immediately would put Trent Radio under too much of a financial constraint. Thus having discussed this with the relevant parties, I propose that for one year Trent Radio will make interest only payments on both the contract obligation and its summers loans.

As part of this proposal, this arrangement would be reviewed at this time next year, and either be continued or adjusted as necessary.

We will endeavour to obtain a positive referendum result to increase our student fees in February 2008, we will endeavour to raise funds from donations and earned revenue of the course of this fiscal year. If we are not successful enough, we must institute plans which will according reduce operational expenses.
