From TRadio By-law #1

ARTICLE IV 4. OFFICERS Election or Appointment 4.01. There shall be a President, and a Chair of the Board, and a Vice-President, a Secretary, a Treasurer, and such other officers as the Board of Directors may determine by by-law from time to time, and as it may from time to time appoint. One person may hold more than one office except the offices of President and Vice-president. The President, and the Chair of the Board, and the Vice-chair of the Board shall each be elected by the Board at a meeting of the Board. In default of such election, the then incumbents shall hold office until his successor is elected or appointed. Officers of Trent Radio other than the President and the Chair of the Board, and the Vice-Chair may, but need not, be members of the Board, and in the absence of written agreement to the contrary, the employment of all officers shall be settled from time to time by the Board.

Duties of Officers 4.02. CHAIR OF THE BOARD - The Chair of the Board of Directors shall, when present, preside at all meetings of the Board of Directors of Trent Radio. He shall ensure the preparation of a proper agenda, including follow-up of matters and responsibilities heretofore assigned, for all such meetings and due notification of the members of the Board of time and place of meetings and where appropriate of particularly significant or urgent matters to be introduced thereat.

- 4.03. VICE-CHAIR OF THE BOARD The Vice-chair of the Board of Directors shall perform the duties of the Chair in the absence or inability to act of the Chair and shall, in addition render assistance to the Chair in the performance of such duties when called upon to do so.
- 4.04. PRESIDENT The President shall, when present preside at all meetings of members of Trent Radio. The President shall also be charged with the general and overall management and supervision of the affairs and operations of Trent Radio. The President with the Secretary and other officer appointed by the Board for the purpose shall sign all by-laws. During the absence or inability of the President to act, his duties and powers may be exercised by the Vice-president or such other director as the board may from time to time appoint for the purpose, and where the Vice-president or such other director appointed exercises any such duty or power, the absence or inability of the President shall be presumed with reference thereto.
- 4.05. SECRETARY The Secretary shall be ex officio clerk of the Board of Directors. He shall attend all meetings of the Board of Directors and record all facts and minutes of all proceedings in the books kept for that purpose and, without limiting the generality of the foregoing, a register of directors and a register of members except in circumstances where the provisions of Section 2.05 (a) of Article II apply, in which case Trent University shall make and keep a register of members admitted as members under the provisions of Section 2.05 (a) of Article II, showing the date of their elections or approval and of their respective retirements or removal. He shall give all notices required to be given to members and directors. He shall be the custodian of the seal of Trent Radio and of all books, papers, records, correspondence, contracts and other documents belonging to Trent Radio which he shall deliver up only when authorized by a resolution of the Board of Directors to do so and to such a person or person as may be named in the resolution, and he shall perform other such duties as may from time to time be determined by the Board of Directors.

Hello all,

First, I would like to briefly introduce myself for those of you who do not know me. My name is Pippa O'Brien, I am in my fifth year at Trent, and I am currently the Vice President Clubs & External Affairs at the TCSA. Under this portfolio I am also the main point person for liaising with the rest of the Trent University Levy Groups (many of which I have been involved with over the years outside of the TCSA as well).

As some of you may know, Trent has switched to a persemester tuition/fee billing structure in response to this change being mandated by the province. As a result they can only really look at and guarantee that students are enrolled in courses each semester, not over the year as a whole. This essentially means that our old distinction of 'full-time' students being those who take 3.5 credits over the whole year is no longer useful. Students know that they only need to register in credits for one semester at a time, and a full semester of courses only adds up to 2.5 credits. All the levy fees currently are being charged to 'full-time' students who are taking 3.5 credits or more, however this group essentially doesn't exist anymore. For this year the finance office is putting in place a temporary solution to retroactively charge students who have reached this threshold in January so what we would have considered 'full-time' students in the past are still being charged the levies this year. So please do not worry about your levies for this academic year. However this is only a temporary solution, in particular it is unfair to students since they do not know that they will be having extra fees in the winter, and is difficult to track for Trent's Finance Office.

For some context, if you are looking at per-semester billing OSAP defines a full-time student to be someone who is taking 1.5 credits or more each semester (1.5 credits is 60% of a full course load of 2.5 credits each semester).

The TCSA has decided that we also need to switch our levy billing to a per-semester basis so as not to lose money from students who are 'full-time' (by OSAP's definition), but are falling short of the 3.5 credit cut off in November when the Trent Finance Office calculates how much income we are getting from each respective levy. My hope is that all of the levy groups can sign on to this change so no one is loosing any money and so that the levy billing system is more clear for students to understand. In saying that, all of the non-TCSA levies are only applicable to students who were 'full-time' (using our old definitions), so therefore would only be charged to 'full-time' (OSAP definition) students under the new system.

We propose that every levy is spit evenly in two and charged to students each semester they meet the 1.5 credit 'full-time' (OSAP definition) status cut off. So for example if your levy is currently \$4 a year, it would now be \$2 a semester (not including summer semesters

when levy fees have never been charged). If a student was taking 1.5 credits or more each semester for a total of 3 or more credits for the year, then they would be charged \$2 each semester for a total income to the levy group of \$4 for the year. If the student was taking only 1 credit in the fall semester and 2 credits in the winter semester, they would be charged \$0 for the fall when they were considered a 'part-time' student and \$2 for the winter when they were considered a 'full-time' student. The same thing would happen in reverse if a student was taking more that 1.5 credits in the fall and 1 or less credits in the winter. Students who drop out or graduate before the winter semester would also not have to pay any fees for the winter semester since obviously they would not be taking courses.

What this means for levy group income is that now you are catching more students under your levy since formerly students who were taking 1.5 credits each semester who would not have been considered 'full-time' (using the old 3.5 cut off), are now considered 'full-time' (using our and OSAP's new definitions). This means that you will now get their levy, thereby increasing your levy. However this will be slightly off-set by the reduction in levy collection from people who are not paying in the winter since they have graduated or dropped out. We expect that these two effects will balance each other, so that levy incomes will not decrease and potentially slightly increase. This is a huge benefit compared to staying with the old system when finance will not be able to charge all 'full-time' (OSAP definition) students your levy since they will fall below the 3.5 threshold (what will happen if you do not agree to this change). Please see the chart attached for the per semester breakdown of levy fees suggested for the new system.

Obviously these changes will need to go to referendum in the spring. What I am proposing is that we all put forward only one question to the students on behalf of the TCSA and levy groups so that we can collectively make the necessary billing changes. It should not increase the amount that most students have to pay and is very much in the spirit of maintaining the levies that students voted on (maintaining them for 'full-time' students, and not charging 'part-time' students).

The TCSA board of directors will be putting forward this question on behalf of the TCSA and all the levy groups. However if you do not want to be included in this change please let us know and we will not include you (though you might begin to loose money unless you propose and put to referendum your own solution). Finally myself and Tracy Milne (TCSA Operations and Services Manager) would be very happy to explain this proposal to anyone in person if you reach out to us.

Trent Radio will be moving into our Entre Season starting on Monday December 12th.

Our regular Fall and Spring broadcast seasons are adjusted to work with the university's "Winter Vacation" period to better accommodate TrentU students' programming obligations. Thus the Fall season ends on December 9th 2016 and the Spring season starts on January 9th 2017.

During this interim, "between-time", we pick a selection of dates and ask our Co-op students to take on the responsibility of an "Entre" season, and run Trent Radio House with support from staff as required. This year's Coop students are Darby White-York, Andie Rodda & Lizeh Basciano

They will be responsible for opening/closing, being on the radio every day, monitoring the broadcasts of others, making sure Trent Radio is in compliance with the CRTC / Industry Canada etc, answering the phone, making coffee - and having all the knowledge about what is supposed to be on the air.

The "Entre Season dates are: Monday December 12th - Friday December 16th, &

Monday December 19th - Wednesday December 21st

Each broadcast day runs from 0900 to 1600, requiring that the facility be opened at 0835 and locked up around 1615.

Morning Shift: 0835 - 1135 (required Darby to secure alternative transportation to make it to 3rd period in time)

Afternoon Shift: 1215 - 1615 (requires both Lizeh & Andie to be available later each day, and be comfortable locking up the building)

One of the Trent Radio's management staff members will be onsite from 0930 - 1530 each day, and available by phone at all times during their shifts.

It is an amazing opportunity for everyone involved, and at writing, I still need to ensure that everyone has permission / support from their parent/guardian, and that each student is 100% committed to the responsibilities (read: time commitment) associated with the season.
