- 3. And a Member of Trent Radio
 - a) at the time of their election, OR,
 - b) within ten (10) days thereafter

 And capable of conduct which is that of passionate disinterest, divesting themselves of self-interest or private advantage

5. And not normally employed by Trent Radio.
