Summer Operations Manager's Report for BoD Meeting 24 June 2008 prepared by Andrew French 23Jun07

Despite a few cancellations, the summer schedule is almost full.

There are open times on Friday from 6pm-7pm (fortnightly), Saturday from 5pm-6pm (fortnightly) and Monday from 7pm-8pm (fortnightly), although there is interest for the Monday opening, which is awaiting a programme proposal from two past programmers. All the programmers have been studious, timely and there have been no conflicts to date. While only two Executive Producers were able to attend a meeting held on May 11th, to date they all to be very courteous and supportive.

The logger system had some minor operational glitches in May and an outage in the early hours on June 1st caused by a power failure, however there have been no problems since. In addition, both telephone lines failed at various times. Of particular concern to programmers, the on-air telephone line worked intermittently until we could determine the problem was at Bell Canada's end. They kindly made repairs a few hours after the problem was reported.

Smooth Operator is going wonderfully with our co-op student Dan Lagana conducting interviews with various organisations within the Peterborough community as well as numerous local artists. His interview skills are growing rapidly and it is a pleasure to see the developments. There have been renovations done to the Trent Radio house, which include making the porch level as well as the application of a new coat of paint. These new improvements, in my opinion, give passers-by the impression that Trent Radio is an unpretentious palace.

Trent Radio's annual Radio on the Lawn is scheduled for Friday, August 8th. Al Kirby, a long time ago and now current Trent Radio programmer and local Bluegrass musician, as well as Misha Paramonov, a Trent Radio Executive Producer and local deejay, have signed on to perform for this event. The outline for Radio on the Lawn will consist of performances by local musicians as well as interviews. I plan to make a number of posters for the event as well as record a promo in order to increase public awareness.

A number of radio project days in the works which should be both entertaining and educational. I've have been in contact with Barney Wornoff from the Shrimps, a local comedy troupe, about having a Trent Radio Comedy Extravaganza Day. It is scheduled for Sunday, August 17th and would entail live comedy in StudioA during the day hosted by Barney and Dan Smith (also from the Shrimps) who are both are trained for StudioA. They play standup and sketch comedy records from the likes of SCTV and the Arrogant Worms among others. The grand finale of the Comedy Extravaganza will be a drive-in movie (the movie will be 'Peterborough Time Cartoon' and will projected on the south end wall of Baskin Robbins with audio broadcast from Trent Radio). The movie will be in three segments with live interviews during intermissions.

I have also been in contact with Kate McNeil, co-organizer of Peterborough's Slam Poetry, in regards to having a poetry/prose day at Trent Radio. The date is scheduled for Sunday, July 27th. The day would entail local poets and writers from the Peterborough community coming down to Trent Radio for readings and interviews as well as prerecorded readings from some of Canada's renowned poets such as Irving Layton and Al Purdy. I plan to create a number of posters (firstly as a call out to local poets and secondly as posters advertising the event) as well as make an announcement at the next Slam Poetry night.

General Manager's Report for the Board of Director's Meeting 24 June 2008 Prepared by John K Muir

- i. 715 Upper Occupancy: Our current tenants gave notice and are leaving on 31 July 08. The legal rent is now \$695 and given that there are no major renovations indicated it is proposed to advertise and have it leased directly.
- ii. CSJ08 Details: It was decided and mutually agreed to hire the Summer Operations & Information Manager commencing Mon, 28Apr08 at 20 hours per week, until we had heard about the CSJ grant. Subsequently, we were advised that we received CSJ funding to cover 12 of the 18-week employment period. The CSJ contract requires that employees work 40hrs/wk during the funded period. Accordingly, and after the hiring committee made its recommendations, Andrew French was appointed to the position. The total wage & benefits burden is \$6,672.21 with CSJ contributing \$4,682, and Trent Radio picking up the balance of \$1,990.21. I am grateful to both Laurel Paluck & Jill Staveley for giving Andrew orientation and support at the start of his duties, and to Andrew himself. Aside from his regular work, which included working with me on a twelve-hour time difference, he has taken on cutting the grass.
- iii. South Porch Maintenance: Hank Fisher was paid \$208 for materials and labour to re-support the structure. Michael & Stephanie Minor were paid \$300 to stain the upper west extension and to paint the porch floor & exterior. Although the floor paint was already on hand, \$205.76 was spent on stain, exterior paint, and related sundries.
- iv. Telephone Trouble: The office line failed, and Pre-tel was paid \$78.75 to find the fault. A few days later, the on-air line failed completely on Bell Canada's end, which they were able remedy quickly. While trouble-shooting, it was discovered that the phone wiring in the basement is needs to be clarified, and should be cleaned up as soon as convenient. This work will be put on the summer shutdown list of things to do.
- v. OWSP & TIP applications for AY2008-09 have been made for the upcoming year and for the same positions that were applied for last year.
- vi. Power outage 01Jun08: As a result of a lighting strike, we experienced a loss of city power for about 65 minutes at about 3am on June 1st. The UPS system in place for our core computer systems is designed to run for about 30 minutes, so when the design time was exceeded and everything shutdown, it had to be restarted manually. While we might consider adding capacity to our UPS system, this is the first loss of power in five years (the August 2003 international power failure) to exceed our UPS capacity. It is therefore recommended to only monitor the situation, to observe whether city power failures become longer and more frequent.
- vii. Summer Financing: We will require a short-term loan of \$10,000 to cover expenses to yearend again this year. Of this \$4,682 will come from the CSJ programme, \$2,500 from a charitable donation.
