## Summer Operations Manager's Report 2013 for BoD 130904 prepared by Kathleen Adamson - SOIM 2013

**Overview:** Programming began on 29 April and ran until 16 August. Starting with 31 programmes and 34 programmers, 3 programmes and 3 programmers were subsequently added, and another 3 dropped out. Broadcast hours were from 17h-24h Sunday-Friday, 08h-22h on Saturdays, for a total of about 54 hours a week. Office hours were 10h-15h & 16h-18h weekdays, with Studio A open for prerecording by appointment.

We had 10 operators scheduled (3 on Monday), covering the broadcast week for most of the summer.

Several "subcategory 36" shows prominently featured radio art, electronic music, and audio experiments. Shows with a literary bent, and there were a number of programmes that began with or developed a literary focus were also popular. As always, the "geek population" was represented with some solid offerings.

Formal social activities included an operator's social at the beginning of the summer at John Muir's house, and an end-of-summer social, hosted by myself.

Event Days: Three "radio day" events took place this summer; Weird Music Day (12 Jun), and Spoken Word Day (12 Aug). Weird Music Day (12 Jun), a popular event day begun by Matt Jarvis three years ago, provides a chance for programmers to try something new; "Glistening chariots, strange barking sounds, Croatian alleles of sound - all of the above and more are welcome". Radio on the Lawn (26 Jul) was a relatively quiet, but enjoyable, day of music, and it allowed Trent Radio regulars to meet and greet a few excellent local musicians. The a prompt sheet document of how to organise the event has been drafted, with a list of media contacts and some suggestions for planning future "Radio on the Lawn" event days. Spoken Word Day (12 Aug) at the end of the summer, was designed to take advantage of the literary direction many of our summer shows had this season - it featured a good deal of pre-recorded content.

**Special Performance Project:** To fulfil my employment obligations to present & produce a performance project, I wrote and staged a short opera, "*Christina Mirabilis*". The performance included Bennett Bedoukian, Jacob Quinlan, myself, and Charity Justrabo in the title role. Anthony Gulston recorded the performance, and it will be kept in the Trent Radio archives. The performance took place at Sadleir House on Sun 25 August, in front of an audience of about 35.

General Comments: I was very pleased with the commitment of both executive producers and programmers. The schedule was consistent throughout the summer, and absences almost always accounted for well in advance. We had several new first-time operators this summer who conscientious, reliable and admirable. Jess Grover and Abram Hawkins, have expressed a keen interest in continuing as Operators in the fall season. The high standard of the summer schedule was also due to the work of a few excellent fill-in operators - Wes Grist and Anthony Gulston dependably volunteered to take over full shifts or partial shifts, and always in the best of humour.

**Statement of Performance:** It is my opinion that Trent Radio's 2013 Summer programming was balanced, of high quality, and met or exceeded all undertakings set out in applications to the CRTC in compliance with all relevant particulars of the "Broadcasting Act"

#### b General Manager's Report

- i. Local Content Management Project: A full report will be presented at the next BoD Meeting scheduled 25 Sep 13.
- ii. Much needed Exterior Work was completed:

Upper deck of the exterior stairs were repaired - \$2,710.02.

Exterior wood surfaces were prepared and painted - \$2,593.35

Extensive tree & hedge removal or pruning - \$4,520.00

- iii. <u>Shutdown & Clean-up</u>: Went well. Our main distribution amplifier coincidentally failed while this was happening, but has been replaced.
- iv. <u>Personnel</u>: My sincere thanks to Kathleen Adamson for her work the SOIM 2013. We're very happy to welcome back James Kerr & Jill Staveley. The PD employment terms include a CPI increase with pay rate of \$15.01/hr at 32hours/wk for a minimum of 40 weeks. In addition to other operational responsibilities the Production Manager (AGM & RRFGM) will take the lead on the upcoming "Trent Radio Kitchen Sessions" (TRKS). The latter is funded by the Community Radio Fund of Canada (CRFC) see attached press release and timeline details below. Employment terms are \$963.87 fortnightly for forty weeks, based on 20hours/wk for TRKS work and another 8 hours/wk to cover other duties. Trent Radio has also paid for a health & drug plan (01Sep13-31Aug14) the cover the PD & PM and their respective families \$1396.82

Peterborough, Ontario August 27, 2013 – Trent Radio (CFFF), Peterborough's community-based radio broadcast facility, is pleased to announce that it received \$20,000 under the Community Radio Fund of Canada's (CRFC) Radiometres program. "For the second time, the CRFC is pleased to invest \$1,000,000 in Canada's community radio sector through *Radiometres* to enable stations to better meet the needs of their communities," says CRFC President, Jean-François Côté. "Whether it is by improving their programming, training volunteers or enabling the community to participate in their activities, campus and community stations strive to remain relevant and play an active role in their communities,"he adds.

Established and operated by the students of Trent University, Trent Radio is designed with the production of exceptional radio in mind. Its aims and objectives include producer-oriented programming and broad community participation for the production of creative local radio. Trent Radio's programmers are by definition amatuers – that is, we do radio for the love of it.

Trent Radio is honoured, once again, to receive funding from the CRFC. This project will also welcome Jill Staveley (Trent Radio's Production Manager/Assistant General Manager, among other things) back to work after a year off to enjoy her second maternity leave in just under 4 years.

"We are excited to have Jill back at Trent Radio house, and we are really thrilled to have her experience and passion for music as a performer and audio engineer at our fingertips to lead the CRFC Radiometres project this year" said James Kerr, Programme Director at Trent Radio. "Jill has spent the past 4 years balancing her time and energy between being a mother, her work at Trent Radio and her role as

Assistant Coordinator at Rock Camp 4 Girls Peterborough. It really hasn't left her much time for being involved in creative and production projects in the same capacity as she used to. The LYM & Kitchen Sessions will undoubtedly offer Jill the opportunity to re-visit her passion for music creation and production, and complement her unwavering commitment to creating performance and artistic opportunities for community members, especially youth, in Peterborough. Trent Radio will also see the fruits of her labours in the form of new and unique content for addition to Trent Radio's Local Content Archives, and for broadcast at 92.7 CFFF FM."
